OUTSIZED VEHICLE TRAFFIC IN THE WINTER PERIOD

(replaces Bulletin No. 04.12.02 of December 5, 2002)

This bulletin has been designed to inform the holders of permits issued under the *Regulation respecting special permits* about the requirements regarding outsized vehicle traffic in the winter period.

Subparagraph 4 of section 11 of the *Regulation respecting special permits* stipulates that a special permit does not authorize an outsized vehicle to travel when visibility does not extend to a distance of one kilometre or the roadway is not cleared of snow or ice in accordance with the maintenance conditions (standards) applicable to that highway.

The maintenance conditions applicable to a highway correspond to the results expected at the end of snow and ice clearing operations. These conditions depend on weather, geographic and environmental constraints as well as on the number of vehicles traveling on a given road, which is often referred to as AWDT (acronym for average winter daily traffic). This number is determined by the Ministère based on its own vehicle counts or its winter statistical data. To help determine whether an outsized vehicle is authorized to travel on a given road, it has been agreed to use new definitions to describe the roadway conditions, so as to make them easier to understand.

Thus, when visibility is greater than 500 m (good visibility) and the basic maintenance conditions have been fulfilled, outsized vehicles are authorized to travel under certain specific conditions. These conditions are indicated in the table on the second page of this document. If any of these specific conditions is not met, traffic is prohibited in accordance with subparagraph 4 of section 11 of the *Regulation respecting special permits*.

For the purposes of this information bulletin, urban road segments and road segments located within the limits of a locality are considered to have an AWDT lower than 500.

It is important to remember that speed must be reduced according to weather and roadway conditions to ensure the safety of road users. Moreover, when conditions do not allow outsized vehicle traffic, the vehicles must be parked in a safe location.

Attached is a document explaining the new terminology for roadway conditions in the winter period and a list of the territorial units of the ministère des Transports which provide information on road conditions, weather conditions and traffic flow.

Additional traffic conditions

0. No conditions
1. The parts of the driving surfaces that are covered with ice or snow at critical points (e.g.: slopes, curves and intersections) must be covered with abrasive.
2. The length and overhangs must not be greater than the limits of Class 1 (general), the height must be less than 5 m and the loads must be within the limits of Class 5.
3. The width of the vehicle, load included, must not exceed 4.4 m.
4. A front escort vehicle is required if the width of the vehicle, load included, exceeds 3.1 m.
4.1 A front escort vehicle is required if the width of the vehicle, load included, exceeds 3.5 m.
5. Transport must not be done within the following periods: 7 a.m. to 9 a.m. and 3 p.m. to 6 p.m.
6. The width of the vehicle, load included, must not exceed 3.75 m and transport must not be done at night for vehicles exceeding 3.10 m in width, load included.
7. A rear escort vehicle is required when the total loaded mass of the vehicle exceeds 67,500 kg.
8. The width of the vehicle, load included, must not exceed 3.1 m, the height must be less than 5 m and overhangs must not exceed the limits of Class 1 (general), the length must not exceed 27.5 m and the total loaded mass must not exceed 67,500 kg.
9. A front escort vehicle is necessary at night for vehicles with a width, load included, of between 2.6 m and 3.1 m.

- Notes**
- If any of these specific conditions is not met, traffic is prohibited in accordance with subparagraph 4 of section 11 of the *Regulation respecting special permits*.
 - Night is defined as the period between sunset and sunrise at a given location.

NEW TERMINOLOGY FOR WINTER ROAD CONDITIONS

<p>Bare and dry: All wheels of a vehicle are on a bare and dry surface over an important part of the road segment for which a condition is given.</p>	
<p>Bare and wet: All wheels of a vehicle are on a bare and wet surface over an important part of the road segment for which a condition is given.</p>	
<p>Partly snow covered: The wheels on one side of a vehicle are on a snow-covered surface over an important part of the road segment for which a condition is given, while the wheels on the other side of the vehicle are on a bare surface.</p>	
<p>Partly snow packed: The wheels on one side of a vehicle are on a snow-packed surface over an important part of the road segment for which a condition is given, while the wheels on the other side of the vehicle are on a bare surface.</p>	
<p>Partly ice covered: The wheels on one side of a vehicle are on an ice-covered surface over an important part of the road segment for which a condition is given, while the wheels on the other side of the vehicle are on a bare surface.</p>	

NEW TERMINOLOGY FOR WINTER ROAD CONDITIONS

Snow covered: All wheels of a vehicle are on a snow-covered surface over an important part of the road segment for which a condition is given.



Snow packed: All wheels of a vehicle are on a snow-packed surface over an important part of the road segment for which a condition is given.



Ice covered: All wheels of a vehicle are on an ice-covered surface over an important part of the road segment for which a condition is given.
